

# Nominations for Election to the Board of Therapeutic Guidelines Limited

The constitution of Therapeutic Guidelines Limited stipulates that the Board shall comprise nine directors.

Directors hold office for three-year terms (commencing on the date from which the person consents to his/her appointment and concluding at the expiration of the third Annual General Meeting of the Company following appointment).

The term of one Director position is to be filled at this meeting and nominations for this position are sought. The Director whose term is due to expire at the meeting is Professor Rowett who, as a retiring Director, is entitled to be renominated and elected for a further term.

If you wish to be a candidate for the outstanding position, nominations must be in writing on the TGL nomination form (see below) and signed by two members who are entitled to vote at the Annual General Meeting.

A list of the competencies that are considered important for Directors is enclosed.

Completed nomination forms must be accompanied by:

- a consent to act as a director (enclosed),
- a curriculum vitae (not more than two A4 pages in length),
- the names of two referees, and
- a letter from the nominee (not more than 500 words) explaining how s/he meets the identified required skills/competencies and how s/he expects to be able to contribute to the Board.

A person who is an existing Director of Therapeutic Guidelines Limited is only required to provide a consent to act as a director.

Nominations for election to the Board must be completed in accordance with TGL's nomination process by 16 April 2025 and delivered to:
